

**PARENTAL/GUARDIAN PERMISSION FORM
(For Adults, Minors and Families)**

I hereby grant permission for [myself /my child(children)/family], _____, to participate in all activities including, but not limited to, swimming, boating, hiking, fishing, bicycling, playing baseball, playing football or other games with _____ in conjunction with Brixen Ivy Ministries LLC, Brixen Ivy Ranch, Galena Beef, Mark Schlenker and Lisa Schlenker (collectively "Property Owners") at 348 Snipe Hollow Road, Elizabeth, Illinois 61028 (the "Property") on the following dates: _____
I fully understand that [I /my child] will be staying overnight, eating and playing with other children at the Property.

With respect to any and not limited to such activities, I hereby agree as follows:

I fully understand and acknowledge that: (a) risks and dangers exist in [my/my child's] use of swimming, boating, hiking, fishing, bicycling, baseball, football or other recreational equipment; (b) risks and dangers exist in my child's participation in swimming, boating, hiking, fishing, bicycling, playing baseball, playing football or other games; (c) my child's participation in such activities and/or use of such equipment may result in injury or illness or death or damage to personal property; and (d) these risks and dangers may be caused by the Property Owners, adult supervisors, other participants, accidents, forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, selection of trail, wind, lightning, weather conditions, risks of falling off of a bicycle, risk of drowning, risk of being hit by a baseball or football or bat and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment, and I hereby accept and assume these risks and dangers with respect to [myself/my child].

Additionally, I fully understand and acknowledge that [I/my child(children)] may interact with livestock, including, but not limited to, cows, chickens, llamas, goats, sheep, pheasants, turkeys, peacocks or horses. While these animals are domesticated, I understand that they are animals, and by their nature, they are unpredictable in their behavior. I accept and assume the risks associated with [myself/my child] touching, petting, feeding or being near these animals.

I affirm that [I / my child (children)] will not be under the influence of alcohol or controlled substance, and will not carry, use or consume these substances before or during my/her/his scheduled activities.

In the event that adult supervisors or guides are present for my child's activity, I understand that such adult supervisors or guides are there to provide a more orderly event, guidance on how to engage in the activity and help answering questions when possible. Guides and adult supervisors are not trained in medical practices or procedures. Guides and adult supervisors are not experts at predicting weather. Guides and adult supervisors cannot predict what other participants might do. Guides and adult supervisors cannot guarantee a quick response to accidents or other emergency situations. The responsibility for my child's safety at all times remains with me, or whatever adult supervisor or authority I have designated for such responsibility. The Property Owners do not and will not accept the responsibility for my child's (children's) safety.

[Myself/My child (children)] is in good health and is at or above the minimum age required by group sponsor for the specific activity in which I/he/she will participate. I understand that strenuous physical exertion may be required, and [I /my child] has no known physical disabilities or health problems which will present any risk related to [my/his/her] participation in the activities. I release and agree to indemnify and hold harmless the Property Owners and their employees, officers, representatives and agents (collectively the "Releasees") from any and all liabilities and damages incident to or arising out of [my/my minor child's] involvement or participation in these programs and activities, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law. I permit the use of any photos, slides, films, or sketches of [me/him/her] taken during the day's activities for publicity, advertising, promotions or other commercial purpose. This Agreement shall be binding on my heirs, successors, assigns and executors.

Any lawsuit, dispute or proceeding arising from [my/my child's(children's)] participation in activities related to the Releasees shall be conducted in the Jo Daviess County, Illinois.

I HAVE READ AND UNDERSTAND THIS AGREEMENT. BY SIGNING THIS AGREEMENT, I INTEND TO BE LEGALLY BOUND TO ITS TERMS. IT IS MY INTENTION TO GRANT PERMISSION FOR MYSELF OR MY CHILD TO PARTICIPATE IN SWIMMING, BOATING, HIKING, FISHING, BICYCLING, PLAYING BASEBALL, PLAYING FOOTBALL OR OTHER GAMES, SLEDDING, ICE SKATING, SNOW SKIING, HIKING, AND SNOWSHOEING ACTIVITIES, AND TO ASSUME AND ACCEPT ALL RISKS ASSOCIATED THEREWITH. AND TO ASSUME AND ACCEPT ALL RISKS ASSOCIATED THEREWITH.
